REGISTRATION

FREQUENTLY ASKED QUESTIONS (FAQ) about GST TRANSITION from 6% - 0%

- Q1: If I have registered and paid the registration fee that is inclusive of 6% GST before 1 June 2018, can I get a refund for the GST paid?
A1: *No, there will be NO refund. The GST paid will be submitted to Royal Malaysian Custom Department (RMCD) accordingly.*
- Q2: If I have registered and received the proforma invoice but I have not made my payment, am I required to pay the GST?
A2: *You may choose to make payment after 1 June 2018. The Secretariat will email the revised proforma invoice to you after 1 June 2018 and you may pay the revised amount (without GST) accordingly.*
- Q3: If Tax invoice was issued, inclusive of 6% GST before 01 June 2018, but I have not made my payment till after 01 June 2018, am I required to pay the GST?
A3: *Yes, you are required to pay GST at 6%.*

SPONSORSHIP AND EXHIBITION

FREQUENTLY ASKED QUESTIONS (FAQ) about GST TRANSITION from 6% - 0%

- Q1: If I have paid the Sponsorship / Exhibition fee that is inclusive of 6% GST before 1 June 2018, can I get a refund for the GST paid?

- Q2: If I have received the proforma invoice but I have not made my payment, am I required to pay the GST?
A2: *You may choose to make payment after 1 June 2018. The Secretariat will email the revised proforma invoice to you after 1 June 2018 and you may pay the revised amount (without GST) accordingly.*
- Q3: If Tax invoice was issued, inclusive of 6% GST before 01 June 2018, but I have not made my payment till after 01 June 2018, am I required to pay the GST?
A3: *Yes, you are required to pay GST at 6%.*
